To practice your rights to access, rectify and cancel your personal data, as well as to oppose treatment, revoke the consent granted for that purpose and know the procedures, requirements and deadlines set forth for that purpose, at any time you can go personally or through your legal representative by means of a written request in duplicate; with a clear and precise description of the relative personal data, and indicate your address and attach the document on which your right is based and a copy of your current official identification (IFE, passport, military card, professional identification card, IMSSS affiliation credential, ISSSTE , or other official identification); If you come through your legal representative in addition to the above, you must present the original document stating the legal representation, and deliver a copy, as well as a copy of the official identification of the latter, in Mariano Escobedo 550, Piso 5. Colonia Anzures. Mexico City, Mexico 11590. Monday through Friday from 9:00 to 14:00 hrs.

It will be understood that you have given your consent for your personal data to be treated and transferred in the terms indicated in this privacy notice, if upon presenting this privacy notice you do not express your opposition. You may revoke your consent in writing by going to our Legal Department, who will process the requests, in accordance with the Federal Law on Protection of Personal Data Held by Private Parties (LFPDPPP).

To prevent unauthorized access to your personal data and to ensure that the information is used for the purposes set out in this privacy notice, we have established internal procedures to avoid unauthorized use or disclosure of your data, allowing us to treat them properly. In case the protected personal data is required by an Authority in the exercise of its functions, whatever these are or should be delivered to the latter in accordance with the general legislation in force in our country, these data will be available to you within the strict compliance with the LFPDPPP, a transfer that does not require the consent of the owner in accordance with the provisions of article 37.
